Friends of Lowell High School General Scholarships

Last year, the Friends of LHS awarded 16 scholarships (4) \$1000, (5) \$750, (5) \$500, (1) memorial scholarship \$1000. the John F. Abraham Jr. Scholarship and (1) named scholarship \$750, the George E. McAndrews Track and Field Scholarship. Students must apply for a scholarship and meet these requirements: graduate from LHS, continue their education at an accredited school/college or serve in the armed forces, participate in school activities or sports, and have a parent who is involved in the Friends of LHS.

Over the years, some of the scholarships have been endowed to memorialize special individuals. Occasionally someone creates a scholarship for a fixed length of time. These past and present scholarships have been named after the following people:

Present Scholarships:

John F. Abraham, Jr. (1963-1980)

John was an outstanding goalie for the LHS Hockey team. His attitude and talent inspired his teammates. He was named to the All-Star team for the Commonwealth Athletic Conference at the time of his accidental death. He was a member of the LHS Class of 1981. This scholarship is endowed through the FLHS indefinitely. Donations this past year were named in his aunt Paula Abraham's memory.

George E. McAndrews Track and Field Scholarship

George, a 1951 graduate of Lowell High School, was a proud member of the Lowell High School Track and Field team. After graduation George joined the Air Force where he obtained skills that would lead him to a career as an Air Traffic Controller. Through the years, George has promoted the values of hard work, generosity, and self-improvement. It is with these values in mind that the children of George establish a five-year scholarship for a graduating senior who intends to further his/her education, whether in college or trade school. Our hope is that this scholarship will help a senior towards their career dreams and maybe one day, they too will give back. One scholarship in the amount of \$750.00 will be awarded annually for five consecutive years to a qualifying student starting with a 2022 graduate.

Past memorialized scholarships: Gerald J. Wayne (1925-1979)

Mr. Wayne was a member of LHS Class of 1943, served as a Navy pilot during WWII, and graduated from Northeastern University with a Civil Engineering Degree in 1950. He helped revitalize the LHS football booster club and played a leading role in creating the Friends of Lowell High School. He was an active and prominent member of several local organizations including the Sacred Heart Parish, Greater Lowell Association of Retarded Citizens, Holy Union Special School, Greater Lowell United Fund, and the Raytheon Company Management Club. He worked at Raytheon's South Lowell Plant for over 20 years.

Lawrence Wallace (1909-1982)

Mr. Wallace was a modest, quiet-spoken family man who was active in his church. He encouraged his children to serve the community to try to improve the City and its organizations.

G. Brent Leahey, Jr. (1966-1996)

Brent was a member of the LHS Class of 1984 and the LHS Basketball Teams of 1982-83 and 1983-84. The latter won the Division 1 North Basketball Championship. He graduated from Georgetown University and Georgetown Law Center and was admitted to the Massachusetts Bar while undergoing cancer treatment. He loved his family and friends, who now raise funds for Cancer research in his memory.

Senator Paul Tsongas (1941-1997)

Sen. Tsongas was a member of the LHS 1958 class. He attended Dartmouth College and Yale Law School and served in the Peace Corps. He was elected to the Lowell City Council, U.S. House of Representatives and U.S. Senate. He was influential in many projects to spur the economic redevelopment of Lowell, including the Lowell National Historical Park, LeLacheur Park and the Tsongas Arena.

LHS Athletic Hall of Fame

This scholarship honors the relationship of FLHS and the LHS Athletic Hall of Fame in supporting athletics at Lowell High.

Slattery Family Scholarship

This 5-year scholarship was established by the Slattery Family in honor of their Lowell High graduates: Mary (1976), James (1980), Sean (1983), and Maura (1985).

Charter of Committee:

The Finance committee oversees financial matters and will make recommendations to the Board of Directors concerning financial matters affecting the Organization as may be necessary from time to time.

Overall Committee Goals, Topics Discussed, Accomplishments and Recommendations: Date of Meeting November 14, 2022

The committee oversees investments, and reviews and monitors the overall financial operation of the organization in conjunction with the president, treasurer, and assistant treasurer.

The finance committee reviewed and accepted the financial statements for the year from 10/2021-11/2022. The first portion of the meeting treasurer, Moira Silva discussed and explained the past years expenditures including sponsorships to the LHS athletic dept for award certificates, medals, and trophies., Hall of Fame dinner and first day of school refreshments for faculty. There was a discussion regarding who would take over managing teacher grants. We also discussed creating three tiers of awards for the FLHS Scholarship recipients. The top tier being awarded more than the middle and bottom tier based on involvement All executive and BOD members were present at this meeting to explain the complete process of accounting practice and the audit process, this was done to benefit the new members of the FLHS. The committee reviewed the current budget, individual committee balances, and a summary of all accounts. The discussion of the budget showed that the FLHS accounts are in good shape for maintaining daily operations, without excessive discretionary funds; the current 15% transfer of fundraising monies will stay in place. The committee will continue to analyze the state of the finances with the intention of returning a portion of committee funds paid to the Friends of Lowell High School during the current year.

The Treasurer will prepare an operating budget for the Friends of Lowell High School operating account and recommend a budget to the Board of Directors for the upcoming fiscal year. The committee will furnish reports as needed.

Charter of Committee:

The Nominating Committee shall be responsible for the nomination of fifteen (15) Directors, including six officers, for election at the next Annual Meeting. The President shall notify the Members of the organization of the names of the Members of the Nominating Committee. At the February meeting of each year, the Nominating Committee chairperson shall provide a form by which any member of the Organization who is not delinquent in payment of dues and in good standing may submit his or her application for membership on the Board of Directors. All applications for membership on the Board of Directors shall be submitted to the Chairperson of the Nominating committee on or before February 28 of each year. Thereafter the Nominating Committee shall nominate fifteen (15) persons to be Directors and shall submit the names of its fifteen (15) nominees to the President and the Clerk of the Organization at the March meeting of each year.

The Committee will review the applications and determine if all criteria is met (zip code of residence, gender, team committee representation, race, profession, etc.)

I stressed the need for a new treasurer, assistant treasurer, Vice President, and Board Members. If there is no one taking over these positions especially the Treasurer, the FLHS will have to change how it operates. If taxes are not filed they will lose their non-profit status. There was no new interest generated for the FLHS this year. Overall Committee Goals, Topics Discussed, Accomplishments and Recommendations:

The committee will meet during the month of May. We will review all applications from the 2022 graduating class and select the 15 awardees and determine which scholarship they would receive. The committee approved three tiers of five with the top tier being \$1,000.00 scholarships and the second tier being \$750.00 scholarships. The bottom tier being \$500.00 scholarships for a total of fifteen. This was due to a vast difference in volunteerism and participation between the top and bottom scholarship applicants. There was no change requested to the eligibility process to the FLHS Board.

Charter of Committee:

To review Quick Books account system used for financial management of FLHS funds and confirm expense accounts, deposits and payments. The Audit Committee was appointed by the FLHS/BOD at its March 2023 meeting. All current officers and BOD members were required to attend to understand the Audit process.

Date of Audit: 03/13/23

Overall Committee Goals, Topics Discussed, and Accomplishments/Recommendations:

The following account Income/Expense ledgers were reviewed for this audit:

Baseball, Girl's Basketball, Boys' Basketball, Ice Hockey, Girl's Lacrosse and Boy's Lacrosse.

Expenses/Disbursements for the previous twelve (12) months were randomly reviewed for the above referenced accounts. The treasurer confirmed the back-up receipts/vendor bills in hard copy format for the disbursement of payment.

All of the audited committee documents were readily available from the treasurer and the required signatures and paperwork were in place. The Committee found the audit to be favorable and that the Treasurer was extremely well organized and proficient. The audited committees had their YTD Income/Expense statements presented to confirm the history and the current balances of each of their respective accounts. All committees who were contacted responded favorably. The Committee will report its findings of this Audit to the BOD at the next meeting.

Recommendations: As with any non-profit, volunteer organization the role of the treasurer requires an individual who exhibits diligence and is extremely trustworthy and organized. The FLHS has been very fortunate to have had individuals in this role who have had these qualities and more, as is the case with the current individual who holds the Treasurer position. Per the FLHS bylaws no one person can hold any Board position for more than three (3) years; the FLHS needs a new person to take on this very important Board position or move towards having outside management for the tasks required to maintain this association.
