Dear Lowell Public Schools Families,

Since we announced our plans to close the Lowell Public Schools, **Governor Baker has declared that all schools in Massachusetts will close for the next three weeks**. This means that the Lowell Public Schools will now be closed until Monday, April 6, 2020. This decision includes canceling all school-related activities scheduled to take place during this period of time. As April 6 approaches, we will continue to provide you with regular updates and additional guidance.

We are pleased to have been able to add four more locations for our grab and go lunch service while school is closed. We will now offer lunch for Lowell Public Schools students at a total of nine sites during the weekdays (see the chart below for details). All students ages 2-18 are eligible for this lunch program. Given the circumstances, students don't have to be present to pick up a meal. A parent or neighbor can pick up the student's lunch. The times and locations are subject to change, so please check the Lowell Public Schools website or Facebook/Twitter pages for any updates.

School registration for preschool was scheduled to start on March 16, and registration for kindergarten was scheduled to start on March 30. **We have delayed both preschool and kindergarten registration periods** and will provide you with more details once new dates have been finalized.

In exercising caution for everyone's health and safety, **as of Tuesday, March 17, both the Central Office and Family Resource Center (FRC) will be closed to the public**, with all staff working remotely. However, families can still access limited services by calling the Central Office at 978-674-4320, or calling the FRC at 978-674-4321.

As a district, we will continue to closely monitor developments with the Coronavirus (COVID-19) and will continue to be in regular contact with our partners at both the city and state level. Even though school is closed for the next three weeks, we will keep you informed throughout this situation.
