





Access to COVID-19 Testing in Schools

- Pool testing results are delivered within 24-48 hours.
- Pools were run on 2/24/2021, 2/25/2021, 3/2/2021, 3/3/2021 and 3/4/2021
- Pooled testing involves mixing several test samples together in a "batch" or "pool" and then testing the batch.

• If the pooled test result is negative, all are presumed to be negative. If the pooled result is positive, a follow-up test will be conducted on those pool members.



Pool Testing Plans Moving Forward

- This is truly a collaborative effort! Our nurses, teachers, support staff, and admin are doing everything possible to make this a positive experience for students.
- *Meetcaregivers* our third party testers are critical to the implementation of this program.
- We will continue to re-evaluate the process and make adjustments as necessary, i.e. the move from 2 test days to 4 test days as participant numbers increase.
- Accurate record keeping is critical at the school level and amongst the testers.
- We need to continue outreach to families and staff to increase participation numbers. Additional consent forms are being submitted daily.



Next Steps if we receive positive pool results

- Parents and Staff will be notified by phone and/or email regarding a positive pool result that they participated in.
- All members of the positive pool will be tested as early as possible once the results have been reported. Most likely the next school day.
- Our nurses will use the BinaxNow rapid test kits to identify the positive individual. In the unusual situation where no individual tests positive, all the individuals in the pool will be quarantined until that person is identified via a PCR test.
- Once the positive is identified, that individual will follow the isolation guidelines as set forth by DESE and then sent home. Any close contacts will be identified and notified as well.

What are the goals for returning to In-Person Learning in school buildings?

Return to in-person learning is dependent on the prevailing data

• Decisions are made based on three-week trends in incidence rate, positivity rate, community-wide spread and in-school transmission following the guidance of DESE and in consultation with the Lowell Board of Health.

The School Committee set the following target dates for returning students to in-person learning, provided the COVID-19 data can improve between now and then:

- **February 22 (per vote of SC on 1/25/2021)** Students in substantially separate special education programs who were previously participating in our in-person learning model
- March 1 Students, who are not in a substantially separate special education program, but were previously served in-person this school year as part of our original school reopening plan
- April 1 Expansion of our in-person learning model to include additional students beyond those who were assigned to in-person learning at the beginning of this school year.









Current Status of COVID-19 Vaccine

Massachusetts - Three Phase Roll Out

- The first group included healthcare workers, people in long-term care, and first responders.
- The second phase began in February and targets those with underlying health problems, people over the age of 65 and essential workers like grocery store employees and teachers.
- Phase three is for everyone else beginning in April.
- If escorting a person over 75 to a major vaccine site, younger person can now get a vaccine too.
- About 350 Lowell School Employees with two comorbidities received their first vaccine on 2/25 and 2/26. Special thanks to Circle Health/Sen. Kennedy for assisting with these special events.
