- If the pooled test result is negative, all are presumed to be negative. If the pooled result is positive, a follow-up test will be conducted on those pool members.

BOSTON (CBS) — Pool testing found a 0.76% positivity rate to date in Massachusetts schools, according to the Baker Administration. Nearly 159,000 individuals in 22,679 pools have been tested. The average pool test is seven people.

“Of the collected pooled tests, Massachusetts is not aware of any in which there was more than one positive individual, suggesting that there is extremely little evidence of in-school transmission of COVID-19 in Massachusetts,” said a statement from the governor’s office.” **“State funding for the testing program has been extended to the end of the school year.”**

Consent Forms

How can my student participate in the program?

To participate in the testing program, you need to **sign a consent form** for your child. You only need to sign up once for the weekly testing. If you decide NOT TO PARTICIPATE, you do not need to fill out the consent form.

This form gives us permission to share student information with the technology platform we use to track testing. Student information will only be shared with the Department of Public Health and other departments if a student tests positive in an individual test.

Process when a we receive a positive pool test

- Parents and Staff will be notified by phone and/or email regarding a positive pool result that they participated in.
- All members of the positive pool will be tested as early as possible once the results have been reported. Most likely the next school day.
- Our nurses will use the BinaxNow rapid test kits to identify the positive individual. In the unusual situation where no individual tests positive, all the individuals in the pool will be quarantined until that person is identified via a PCR test.
- Once the positive is identified, that individual will follow the isolation guidelines as set forth by DESE and then sent home. Any close contacts will be identified and notified as well.



Updated COVID 19 Guidelines (5/18/21)

- Students do not need to wear masks outside even if distance cannot be maintained. This applies to recess, physical education, youth sports, and outdoor learning environments.
- At this time, adults and students must continue to wear mask indoors in K-12 Schools..
- Schools no longer have to avoid sharing objects. This includes classroom materials, items for physical education, or art supplies. Shared objects no longer have to be cleaned or disinfected between use and all high touch surfaces should be cleaned once a day. As is usual and customary, any time there is a confirmed COVID-19 case, the space they were in should be cleaned and disinfected.
- Gathering limits for outside event are being lifted starting May 29, 2021.
- Schools and classrooms should continue to maximize ventilation and air exchanges in schools and classrooms, even in warmer weather. Schools should target 4-6 air exchanges per hour through any combination of ventilation and filtration by keeping doors open, using portable air purifiers, and/or keeping windows cracked open one or two inches.
